Although your House Committee has not been able to meet face-to-face, we have been meeting virtually and working hard, along with Club Managers Kim, Sue, and Nicky, to make some alternative plans. We are excited to report that MYC will begin offering takeout food and beverages, effective Friday, June 5.

Initially the hours of service are as follows:

Friday: 5:00 to 8:00 pm Saturday: Noon to 8:00 pm Sunday: Noon to 8:00 pm Wednesday: 4:00 to 8:00 pm

The staff have been putting the final touches on a limited takeout food menu, which will be posted on the MYC website and by email when available, along with instructions for ordering. The menu will also be posted on the patio door. There will be no direct staff contact, in an effort to keep them as safe as possible. Members will call in orders to the main MYC phone number (231.755.1414) and be told what time it will be ready for pickup. Payment will be by member charge only; no cash or credit cards will be accepted.

Limited bar service will also be available. MYC holds a Specially Designated Merchant (SDM) License from the Michigan Liquor Control Commission, which allows members to purchase packaged beer and wine for takeout. A list of available items will also be forthcoming.

Please keep in mind that this is a temporary situation. In the meantime, we appreciate your patience.

#### MYC SAILING SCHOOL AND JUNIOR PROGRAM POSTPONED THROUGH JUNE



The MYC Sailing School and MYC Junior Program have postponed the start of all sailing classes and Race Team activities until at least July 6. Other youth programs in West Michigan have recently made similar announcements.

The Junior Committee is monitoring the COVID-19 situation very closely. We are communicating directly and frequently with state and local health authorities, the leadership at US Sailing and several other organizations to stay on top of any mandates or guidance that may influence whether we conduct any youth sailing activities after July 6.

If youth sailing activities do resume later in the summer, our class sizes may be limited, our curriculum may need to change to maintain safe social distancing, and sanitation procedures may need to be implemented.

Please be patient and rest assured that we are working hard to pe prepared and will take prompt and appropriate action as soon as we know more.
