## House Committee Report:

MYC House Committee Meeting November 14, 2020 10:00 AM

SUMMARY OF MINUTES:

*The House Committee met on Saturday, November 14, at 10:00 am. The October 2020 financial report was not yet available. Please note that a new shutdown by the MDHHS was announced later that day. This report reflects decisions made prior to the latest shutdown.*

### General Manager's Report

A new position has been created in the kitchen to better reflect job descriptions. The Kitchen Manager position will be a dual partnership in the kitchen with newly hired Adam Davis and our veteran Scott Williams. Adam Davis started in early November and is doing a great job! Scott has been promoted to this position. After training is complete, Adam will work days and Scott will work afternoons through close. Still searching for a line cook, but because of low sales, hiring is not urgent at this time. Features have been great so far!

### **SOCIAL REPORT**

**Jam Sessions** - A member contacted Kim to see if the Jam Sessions would be allowed due to the Covid-19 restrictions. After lengthy discussion regarding the risks involved, the committee voted to table a decision until the February meeting. There are other avenues for membership activities that could be socially distanced and we need to think outside the box to support the Club in other ways.

**Christmas Eve Potluck:** Thursday, December 24, open 4-8 for member fellowship. Since potluck style is currently strongly discouraged by the Michigan Department of Health and Human Services (MDHHS), alternatives for the Christmas Eve Potluck were discussed. Further discussion was tabled till the December meeting.

**New Year's Eve:** Tabled till December.

### **NEW BUSINESS**

Hours of service for the coming months to increase, since we have additional staff in the kitchen. New hours are as follows:

- Wed - Thur: Bar 4:00 to 10:00 pm; Kitchen close at 9:00
- Fri - Sat: Noon to 11:00 pm; Kitchen close at 9:00
- Sun: 1:00 to 9:00; Kitchen close at 8:00

**January Shutdown:** After extensive discussion regarding a Club shutdown in January, the decision was made to table the decision until the December meeting. The staff have done a tremendous amount of work during past shutdowns when we would otherwise have very little activity at MYC. The Club has enjoyed cleanliness and positive reports from the County Health Department due to these annual closings. Although the building has had very little traffic over the past year due to Covid, the Kitchen needs to be thoroughly cleaned yearly. The rest of the Club has been sanitized every single day as required and is clean. A list of any necessary projects to be done will be compiled.

**Blanket Drive:** The Club has done food and sock drives in the past. This year we are asking for donations of blankets and socks for all ages. A collection box will be located in the foyer and items will be delivered prior to Christmas.

**Reciprocity/Guest Policy:** The Club rule regarding reciprocity was reviewed due to Covid restrictions. The decision was made to continue to honor as in the past. It was also clarified that the clubhouse is currently for members only due to capacity restrictions. This means guests are currently not allowed in the clubhouse.

**Sales:** There has been a decline in weekly sales since the weather has changed and people have moved inside. This is not unique to MYC. Dining at our club is a much safer option than at other restaurants that are open to the public. After discussion it was decided to offer a to-go menu to non-members one night a week. Our current take-out option is under-utilized. It will be advertised on the Beachwood-Bluffton Neighborhood Facebook page and also on the page for the Lakeside Neighborhood. The target date to begin is November 25.

**Queen's Cup 2021:** Planning will begin in early winter for the 2021 Queen's Cup finish at MYC.

**First Minute in the Water: Presentation by Chicago Yacht Club** will be streamed on November 21. We will set up to stream to all big screens Club TVs and plan a lunch feature.

## Race and Regatta Committee Report:

The idea was hatched on the previous Tuesday. Either Will Osterink or Scotty Miller is the author. Both would deny if things went poorly and both would own it if it was a success. Facebook PM, text messages, emails... and commitments were made. At least three boats were committed.

A race, MYC to B and back, or something like that. Anyone can race and everyone can race, but since the only boats available were the Melges 24s that were on the hard, the fleet would be limited. No RC boat. No RC.

At around 11:00 AM some crew and owners started to gather in the parking lot. Some of the boats had to be put back together. All had to be launched and the teams had to agree on a race course and some rules. The wind was from the south with enough strength that a reach to B and back did not seem ideal. Finish: First boat with feet on the main dock Winner Winner Chicken Dinner!

Three boats made it to the line (Dock) Will Osterink (USA 491) Sam Nedeau (USA 86) and Scotty Miller (USA 142) A smattering of crew, some of each boat's regular crew, some others thrown in. Corinne

Nedeau and two of her MSU Sailing team mates drove in from East Lansing. Becca and Jim Beebe used the race as a warm-up to their last Lake Michigan swim of the year (yeah, WTH) At least one of Scotty's crew jumped aboard Will's boat. At the last minutes Becca traded herself to Scotty's boat, for no one!

At 1:00 PM Scotty did the count down, 3-2-1 GO. All three crews push, jumped, hoisted, yelled, and off they went. It was a one-legged beat to the Torresen mooring, then a reach to the Schiller "no wake" buoy. Will was leeward of Sam, taking him up something crazy, but Sam could not see Will as the main was being hoisted. Fortunately, Sam's main went up a bit faster and he got over Will. Scotty came screaming down from being the windward boat at the start and for a quick second, it looked like the first rounding was going to be an overlapped pinwheel... which would be fine, except for the fishing boat sitting about a Melges 24 width off of the Torresen mooring. To go wide or to thread the needle? Thread the needle of course, and do it while yelling at the fishermen to provide room... They did, Sam got around first, followed by Will and then Scotty... Spinnakers Up... Kind of... And that is the way the boats would eventually finish, but not before some serious fun. Downwind speeds in the teens. Upwind speeds were in the high sixes too due to the all the crew on the rail... Fun meter pegged.

Pure Fun. So much fun that Nedeau even loosened his Dutch wallet and brought a round for everyone at MYC.

This race was not organized by the Race and Regatta Committee. It was club members looking ahead at the weather and seeing a fall weekend window to sail one last time. It was club members taking advantage of one of the best race tracks in the Country. It was doing what we all love to do and doing it in the spirit of how it should be done.
