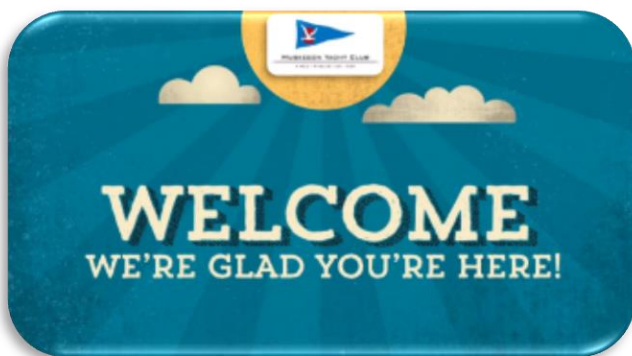

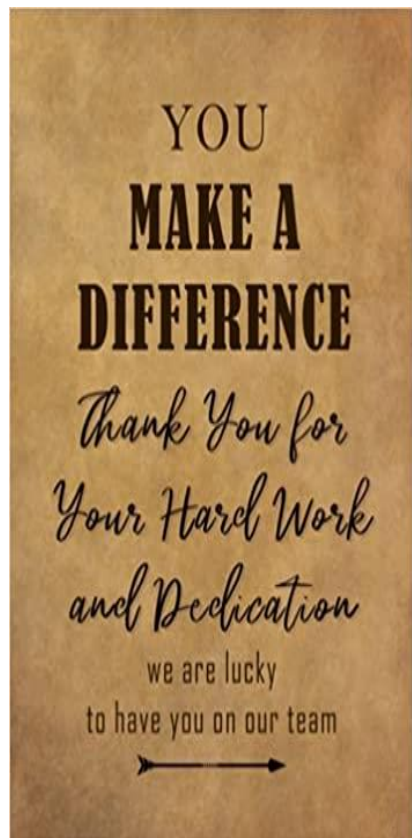

2022 Chubb US Junior Championships Qualifier Regatta:



On July 13-15, Muskegon Yacht Club hosted the Area K Bemis & Smythe Qualifiers for the 2022 Chubb US Junior National Championships.

ABOUT THE CHUBB US JUNIOR CHAMPIONSHIPS

The Chubb U.S. Junior Championship is U.S. Sailing's National Championship for junior sailors, aged 13-18. The Championships are comprised of three separate championships: singlehanded, doublehanded and triplehanded. The singlehanded fleet (Smythe Trophy) is raced on Laser ILCA 6 boats and the doublehanded fleet (Bemis Trophy) is raced in Club 420s. 2022 marked the 101st year of this competition.

Junior sailors hoping to compete at the National Championship must qualify to represent their part of the country at their respective Area's Qualifier event. Each of the **11 Areas recognized by US Sailing** (as shown on the map below) send two teams each to the single and doublehanded National Championship Finals. Area Qualifiers are great events for Junior Sailors to compete against the best sailors in their region without having to travel too far.



In accordance with this qualifying process, the top two boats in each fleet at MYC's Area K qualifier event advanced to compete against the qualifying sailors from the other 10 Areas of the country at the **2022 Chubb US Junior Championship Finals** hosted by Macatawa Bay Yacht Club on Aug 9-12.

THIS EVENT WAS "IN THE WORKS" FOR A LONG TIME

MYC's preparations for this qualifier event began way back in April of 2019 with original plans being to conduct this Qualifier regatta in 2020. Due to COVID, the 2020 Chubb US Junior Championships did not take place. In 2021, the Championships were held at Eastern Yacht Club in Marblehead MA to commemorate the 100th anniversary of the event being held there. In the midst of all these scheduling changes, it was decided that MYC would host the 2022 Area K Qualifiers, and Macatawa Bay YC in Holland MI would host the Area K Triplehanded Qualifier and the 2022 Chubb US Junior Championship Finals. It is a distinct honor to be selected to host these events!

THIS EVENT ATTRACTED 36 OF THE MIDWEST'S MOST COMPETITIVE SAILORS
 Several of the sailors arrived directly from other National and North American Championships as far away as California. The competition was very close in both fleets. All the competitors and visiting coaches greatly appreciated the professional race management provided by MYC and were very impressed by the quality of racing that can take place on Muskegon Lake.





One of the primary benefits of this event is the presence of highly qualified coaches and their very informative daily mandatory de-brief sessions with the sailors. Note all the smiles in the photo above. This is an excellent example of the overall spirit that should be present at every youth sailing event.

This 2-day regatta was extremely well reviewed by all in attendance. In addition to the awareness generated by social media, Sara Renz from *Sailing World* magazine was in attendance and promoted the event within her circle of influence. Coach Cappy Capper, who has served as US Sailing's Area K Championships Representative for nearly 30 years, remarked that this was among the best run Area K qualifiers in his memory.

In addition to MYC hosting the Area K Bemis & Smythe Qualifiers, MYC members Scott and Lisa Corder contributed significantly to the **2022 Chubb US Junior Championships Finals** at Macatawa Bay YC where Scott served on the Planning Committee and as the Principal Race Officer for the singlehanded Laser course. Lisa Corder served as Scorer for the Laser course and assisted in the Judging and Hearings process.



Dock and Yard Committee Report:

This has been a long time coming but Dock & Yard is happy to report that the repair work to the outer wave attenuator is complete. You probably have notice that the barge and crane are gone and then again maybe not since it has been very common for the barge and crane to disappear and then reappear.



The final alignment of the outer wave attenuator

Below is an aerial view of the completed outer wave attenuator with location and elevation data that was also recently obtained by a survey company.

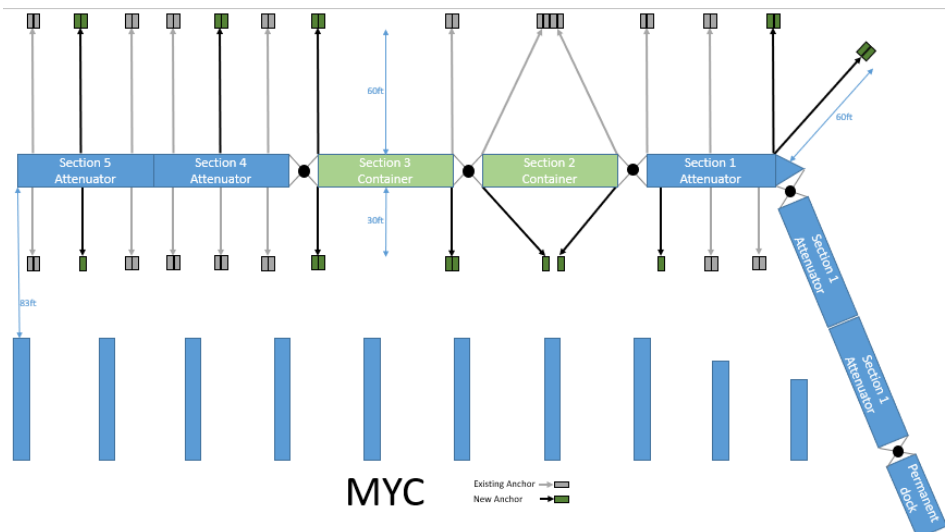


As you will note in the above photograph there are gaps that have been left between sections of the outer wave attenuator. These “engineered” gaps have been left in place to allow independent movement of each section without being able to hit each other. Cross-chains with a large “bumper” tire has been installed in each gap to create a continuous connection of the overall outer wave attenuator so that each section of the attenuator will help support the location of other sections in the event of significant wave action.

In summary the repair to the outer wave attenuator included the following:

- Removal of the damaged sections of “original” wave attenuator;
- Replacement of damaged sections with two (2) modified shipping containers;
- Repairs to left in place “original” wave attenuator sections that had minor structural damage.
- Existing outer wave attenuator concrete anchors were located and re-positioned;
- New concrete anchors were installed and/or doubled up with existing anchors;
- New dock piling was installed at “B” dock to help support the floating docks from increased wave activity, and;
- Repair to broken “B” dock piling hoops.

The majority of the above effort was locating existing concrete anchors and re-positioning each of the attenuator sections. Below is a map detailing the location of each 3,500 pound anchor.



In total MYC now has 87.5 ton of anchorage holding the outer wave attenuator in place. 49 ton holding it in place from the east and 38.5 ton holding it in place from the west.

In other D&Y news we recently have been working on the the following projects:

- Installation of three (3) bubblers along the seawall to create water movement to reduce the amount of algae and weeds from collecting in the marina;
- Repair of broken lights on the marina power pedestals;
- Repair of the inoperable water spiggots on the marina pedestals;
- Yard cleanup of the excess lumber stockpiled in the Melges boat area;
- And other odd & end work.

D&Y wishes to thank each and every volunteer who has given up their time to help complete the long list of projects to keep the marina and grounds maintained.

Additionally, D&Y requests that members make an effort to clean up after themselves. If a member has a boat part or other item that is garbage and will not fit in the trash cans it is asked of you to please take the time to throw your item away in the dumpster located within the white fenced area south of the clubhouse.

For those of you who donate scrap lumber for the fire pit, please bring that lumber cut to size to fit in the fire pit. Pallets and large dimensional scrap lumber will not fit in the fire pit. The area between the clubhouse and the pool continues to be a dumping ground for construction project waste. Wood must not exceed 24-inches in length.

Dock & Yard meets the second Saturday of every month at 9am at the club. You are welcome to attend the meetings and get involved.

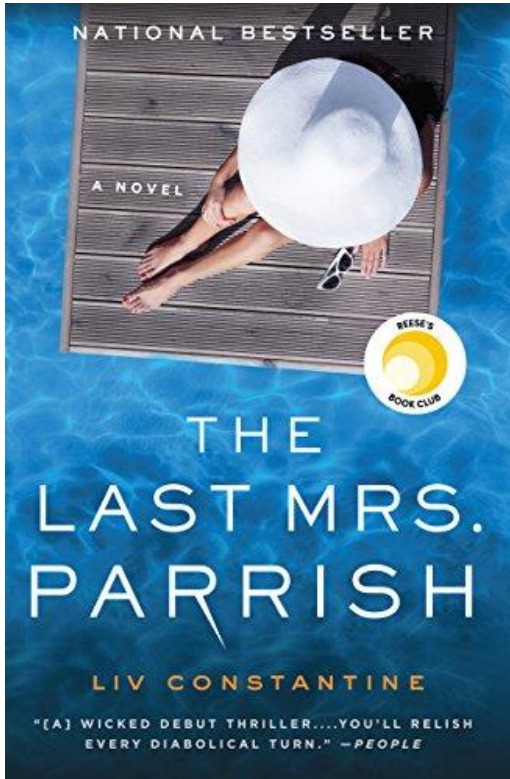

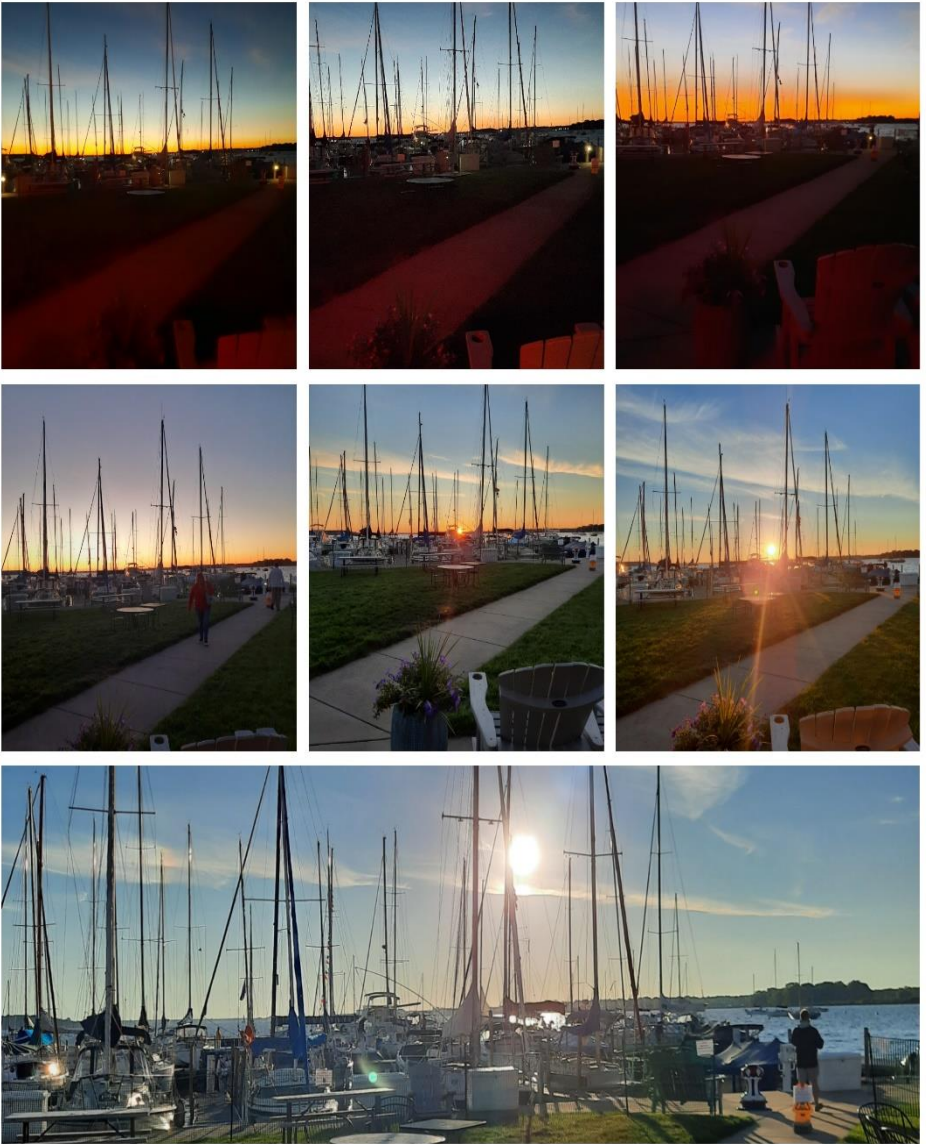

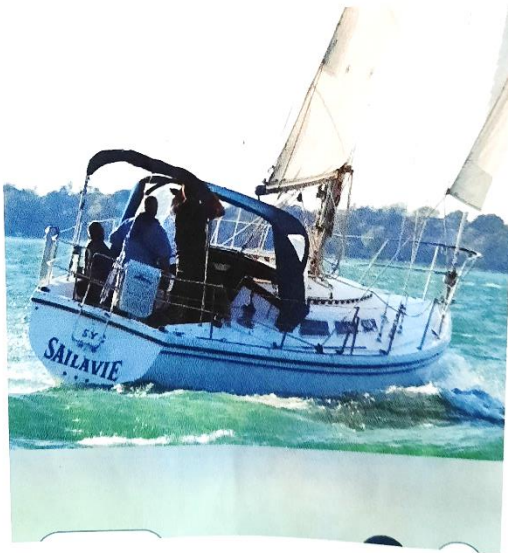
